Again, thank you for your interest in becoming an Eleotin® distributor. Now you have been approved to purchase as a distributor; please read the following guidelines.

The following are expectations we have for distributorship applicants:

1. In order to qualify as a distributor, there is a minimum order dollar value of \$360.00.

Your first purchase should be \$360.00 or more to be qualified as a distributor, and it is also required minimum purchase of \$360.00 within every 6 months to maintain your distributorship.

Please remember to inform customers that each person should take a minimum of 3 to 6 months of Eleotin® before they see the beneficial results of Eleotin®. Please inform your family or customers that they should consult their physicians before they change their diet, or any intake of prescription drugs or insulin. For your information, our reading materials such as books and Medi-reports are available for you. We also have English, Japanese, Korean, and Chinese versions of educational DVDs, so let us send t to you for free when you place your first order.

Please visit our product site at: www.eastwoodcompanies.com in which you will find a variety of products. Let us emphasize the books and DVD's are the effective marketing tools as well as stable income generators. Please consider order enough quantities of books and DVD's.

2. If you plan to distribute Eleotin® through the Internet, keep the price in line with the current retail price of the products on our website.

Make sure your Eleotin® product prices are equivalent to our current retail price. Again, complying with the local regulations and laws is very important. Failure to do so may result in termination of your distributor account.

3. Distributor order can only be processed by phone, email or fax with your product consultant.

- 4. Only crazy people, deceptive people, foolish people make such 'huge' claims when they are not true.
- 5. Now, let's look at who made such claims and who supported/corroborated those claims.

Issue A-2: Windows of Opportunity

Windows of Opportunity

- There are only a few windows of opportunities where it is EASY and CRITICAL for us to CONTACT recent customers or they will be lost.
- 50% of lost patients are from Kevin Trudeau because in his book he told everyone to only order one month of the Mb Pre-brew tea for weight loss, so for these patients introduce new products
- "Brief Introduction to Eleotin®" article is working better at getting contact responses, according to Sean.
- Identify "grey" patients (not so sure about Eleotin®), because contacting them will benefit them the most.
- Some people don't like to be contacted by phone, so use the email scripts and play voicemail to inform them to check email.

The 3 Windows

- 1. When distributor is ordering (most profitable and optimal point, such as introducing new products like Neuro-Health, "upsell" by mentioning other products, also remind them of Critical Phrases so they can use on their patients)
- 2. After patients 1st month of use (most of them are deciding to reorder or not), so if there is only on one time to make a contact, this is it. This is the most Critical Contact Point. Will need to (a)evaluate how Eleotin® worked for them, (b)Critical Phrase, (c)explain expectations based on their evaluation.
- 3. Immediately after (re)ordering is also a window of opportunity. They may only need a Critical Phrase by email.

The Critical Phrases

Eleotin® does not *control* your blood sugar; it *restores* your body's own ability to metabolize blood sugar. Eleotin® is a Functional Restorer which *heals* the *core* of your metabolic system.

Drugs are Chemical Controllers which control your blood sugar by *manipulating* and *hiding* the *symptoms*.

Many Health Foods and Lifestyle improvements are Natural Controllers which soothe the symptoms.

Eleotin® treats the root causes. Drugs and other natural treatments treat the symptoms.

Side effects are the most important factors for determining whether a treatment is suitable for you, and the intensity and duration of the treatment. Eleotin® users experience a lot of positive side effects.

"Eleotin® is not ALTERNATIVE MEDICINE. It is COMPLIMENTARY MEDICINE. It works together with exercise, diet, and a good lifestyle. There is no ALTERNATIVE to exercise, diet, and a good lifestyle. - 2. Credibility
- 3. Price: Do not sound like a salesperson.
- 4. Being overwhelmed by the quantity of Information: Do not start a huge lecture.

Therefore, we have to overcome the above three thresholds. Please refer to the following sample e-mail. Our realistic goal is not to make a sale, but to make them contact us.

- 2. Make sure they stay on their current treatments, which is insulin injections.
- 3. Our products are 100% safe. Emphasize this.
- 4. Ask any Type I diabetes doctor about Dr. Yoon, who is the inventor of the original Eleotin® formula, is the very person who discovered that Type I diabetes is triggered by Coxsackie virus. He claimed in research for our company that 2 years of Eleotin® treatment can cure Type I diabetes. The formula was developed for type 1 originally
- 5. But, we do not make such a claim and we mainly target Type II patients: So far we do not have enough number of cases. As of 2010, we have about 50 cases. Most of them reduced insulin injections by 50-70%, almost permanently. A few claimed being cured. (If you go to our testimony section, you can actually watch the video clip)

Thank you for displaying interested in our products. We are confident that we are able to assist you. I would like to ensure you that our products are 100% natural and safe, but also

remind you that Eleotin® is not a miracle instant cure. You must stay on your current regimen of insulin injections.

Ask any doctor about Dr. Yoon, and you will hear about how he discovered the Coxsackie virus' connection to Type 1 diabetes. He was the inventor of our Eleotin® Formula, which he claimed in research for our company that 2 years of Eleotin® treatment can cure Type I diabetes. The formula was developed for Type 1 originally.

We at Eastwood Biomedical do not make such claims simply because we do not have the quantity of information needed to justify them commercially. In the patients, roughly 50, we have seen reduced insulin injections by 50-70%, almost permanently. A few claimed being cured. - 2. Remind them of the length of time they need to experience the full benefits of Eleotin®. Refer to the "No-results client" document for more details.
- 3. Remind them of the difference between pharmaceutical drugs and Eleotin®. They must not stop their injections or medications.
- 4. Be sure to educate them about "How Eleotin® Works" which is the most frequently mis-informed item. Refer them to "The Wrong Way of Using Eleotin®" website.
- 5. Edward Hum believes that the "Tree of Health" is better.
- 6. Please refer to "Windows of Opportunity"

SAMPLE LETTER:

Dear Customer,

Thank you for purchasing Eleotin®. You will soon be experiencing the benefits of a scientifically proven herbal remedy. However, there are several issues regarding the consumption of Eleotin® that you must keep in mind.

Eleotin® does not work instantly. Some customers see benefits as early as a few weeks. However, be sure to stay on the daily dosages for as long as possible. Also, do not stop any injections or medications prescribed by your physician. Eleotin® is a complementary remedy, meant to help your body learn to become healthy by itself, not to just suppress the symptoms. Be sure to check out our website and make sure to look through all the materials given with your order, including gift certificates and samples of other Eleotin® products. There is invaluable information contained.

We hope you are happy with your purchase. Remember, we have consultants ready and willing to answer any question you may have.

Issue C-1: Temporary rise in blood glucose levels

POINTS:

- These customers must be in panic understandably. We should be really aware of this mental state. Never make these people feel that they are responsible. Repeat "Let us help you" Make it sure that these people are contacted a few times.
- 2. Be confident as we have lots of combinations to suite virtually every person.
- 3. Customers usually have:
 - had lifestyle changes: increased stress, sickness, flu, etc.
 - stopped their current treatments
 - allergic to some herbal treatment.
 - weak livers or kidney problems:

Also go over with him "Wrong ways of using Eleotin®"

- 4. A solution is to reduce the dosage or suspend the treatment and see what happens after one week.
- 5. If there is still a rise, recommend the morning formula only. Quite likely that even customers with the above causes will also experience some benefits. If so, replace all the bottles with morning formula free. Also, try our Detox Products. It is virtually impossible for anybody to experience the rise of BGL in response to our Detox. If the customers keep on experiencing the rise, we may consider refunding the products. But, this should happen after we exhaust the above attempts.
- 6. Also refer to the issue "A diabetes (or obesity) customer wants to know why they have not seen any results yet" (omega fatty acids spike BGL, etc.)
- 7. Also, there are "Homeopathic symptoms" or "Detoxification effects". These occur when the customer is not used to herbal treatments and can result in mild headaches and dizziness. These effects will guickly disappear within 3-4 days as they adjust to the herbal treatment.

SAMPLE LETTER:

Dear Customer,

I am sorry to hear about your rise in Blood Glucose Levels. We at Eastwood are determined to ensure your safety and health. There are several variables that could cause a rise in Blood Glucose levels. Have there been any changes in your lifestyle, such as eating habits, exercise, and stress? Have there been any other side effects, both positive and negative? Have you been sick recently?

First and foremost, Eleotin® is not miracle instant cure. You must continue to take all of your injections and medications as directed by your physician. Omega 3, 6, 9 fatty acids are good for the body but cause temporary spike in blood glucose levels. If you are taking them, stop for a while and then test.

Rarely, a rise in BGL could indicate serious liver and kidney issues. Check with your doctor to make sure your liver and kidneys are healthy. Also, some people are allergic to herbal treatments. In both cases, reduce the dosage and see how your BGL are after one week. If the levels are still high, try to take the morning formula only.

As we have a wide variety of health products, we should be able to suit your specific needs. Please talk to one of our consultants and find the right combination for you to maximize the effect of our herbal remedies.

Issue C-2: Asking for Testimonials and Referrals

Dear Customer,

We have many unsolicited testimonials (click here to see <u>Eleotin® Testimonials</u>). These are just only a few of what we have. They are real testimonies from real people. In the past, Eastwood Biomedical did not really make any efforts to solicit testimonials from our clients. In order to establish our credibility, we thought we would rather rely on clinical studies done systematically at prestigious research institutes and governments rather than personal testimonies (click here to see <u>Scientific Studies</u>).

But recently, we began to realize that most of us need personal testimonies from people just like us whom we can relate to, rather than complex scientific studies which only professionals can fully understand. Research studies are for scientific debates, but, testimonials are more valuable for real life encouragement and application.

Therefore, we have now changed our policy to start seeking testimonies from our clients.

We want your testimonies. It is an act of great endorsement and powerful encouragement to us, and others who are still suffering from metabolic disorders, such as diabetes. Please just reply to this email with a few sentences about your experiences using Eleotin®. We will give you a **(Decide what to give at that time. You do not have to give anything)** as a show of appreciation.

P.S. If you feel like helping other fellow suffering patients, then this would be a good tool for your friends or other people to benefit from reading your testimony on our website. You may even become one of our distributors.

Issue D-1: A diabetes (or obesity) customer wants to know why they have not seen any results yet

POINTS:

- 1. You should remember that our product is the only one that has such cure rates and such long lasting benefits proven scientifically. Do not be discouraged. It is almost sure that they must have experienced some benefits. At least, Eleotin® helped in their prevention. This is the most important point. Be confident.
- 2. Also, be humble. No matter what we do, there will be some things we will never know. Do not pretend that you can answer all the questions.
- 3. Ascertain reasons, as much as possible, why they are not seeing the results they expected.
- 4. You should fully understand that they spent quite a bit of money on our products.

Consultant should ask these questions and be prepared to give the answers

Q1) How long have you been taking Eleotin®?

Of course, such a fundamental approach takes time. The expected progress of Eleotin® treatment differs according to age, lifestyle, and more importantly body size. In some cases, no progress is observable even after 6 months of continued usage. Do not be disappointed. Be patient.

Eleotin® is not a miracle quick fix. You cannot reverse in a couple of months a disease that has been developing over many years. Long-term stable and consistent intake is necessary and essential to the success of using Eleotin®®. Patients who are quite overweight may need to increase their dosage or take a booster called Express 6. Some users feel great energy and also see their blood sugar levels drop soon after starting their Eleotin® treatment. But, these symptomatic improvements do not mean that the fundamental changes have completed or have even started yet. Eleotin® needs to be used continuously and consistently until the body's own ability to control its blood sugar has been completely restored.

We are committed to helping you to achieve the fundamental changes.

Because Eleotin® is made of 100% natural herbs it does not develop resistance even with long-term use. There are no negative side effects and the dosages can be increased without any harm. However, drinking too much alcohol may decrease the effectiveness of Eleotin®®.

Here, note that some consultants are of opinions that doubling or tripling are not really helpful. Sometimes, it makes the situation worse. Dr. Kim's opinion is that Eleotin® is an extremely safe product. Allergies, liver problems, kidney problems are the main causes for negative responses, so far as he knows.

Do not discontinue Eleotin® prematurely even though you may feel much better and your blood sugar level drops, or you feel your weight loss is sufficient. Eleotin® improves the overall health thus it produces many positive side effects. But, prematurely discontinuing Eleotin® may jeopardize your investment in the long-term fundamental changes. Eleotin® takes time.

Q2) Did you take the proper doses? (acquire customer information about weight, as overweight customers need double doses.)

Overweight and severely diabetic people should double the dosages, maybe even triple them. In fact, Chinese doctors are recommending Eleotin®users in China to triple the dosage during the initial few months and then go into a maintenance mode afterwards. Eleotin®is a perfectly safe product even in high dosages. I personally take triple dosages almost everyday even though I do not have diabetes, and am in a normal weight range. I know that what is in

Eleotin®is good for my health anyhow. When taking more than one dosage, some clever people use the capsules and teas at the same time, rather than multiplying the same treatments. For example, one Eleotin®Gold capsules + Eleotin® Express 6, or Eleotin®Gold capsules + Eleotin®M tea. For weight loss, Mb Tea + Mb Concentrate capsules are highly recommended.

Q3) Did you drink alcohol often?

We found that <u>heavy drinkers</u> reverted back to their original diabetic or overweight state even after the Eleotin®treatments improved their health.

Q4) Were you taking Omega 3, 6, or 9?

Although healthy for you, they temporarily spike up your BGL. Do not take more than 500 mg a day. If possible, take them in natural forms, rather than in pills.

Q5) What was your diabetes condition (BGL), diet, lifestyle, weight, energy level like? How is it now comparatively?

Establish that BGL numbers and overall health are sometimes different.

Homeostasis (the body's ability to keep BGL and other levels stable) is much more important than numerical values.

There were many of us, whose Blood Glucose Levels are around the border line, and, whose Blood Glucose Levels fluctuate between 100-150, (5-7.5 roughly) occasionally. Some of these people used Eleotin®, and, Eleotin®appears to be in-effective in lowering Blood Glucose Levels. Also, in case that people were experiencing hypoglycemia (occasional and too low Blood Glucose Levels), people will even see the rise of the Blood Glucose Levels after Eleotin®treatment. Again, Eleotin®is not just a Blood Sugar Lowering agent. It purports to restore the body's ability to normalize the Blood Sugar Levels. Therefore, if you just look at how much Eleotin®lowered the Blood Sugar Level, and, if you look at those of us who are already normal or near normal, it is possible to say that Eleotin®did not change the Blood Sugar Level for these people. For these people, the benefits of Eleotin®would be mainly preventive and fewer and narrower swings of the Blood Sugar Levels. If this is the case, I would not worry too much. Keep on using Eleotin®for preventive purposes so that the 'diabetes' does not get worse. But, do not be disappointed that Eleotin®does not bring your Blood Glucose Level to 100. If you read the science section of our website, this is well recorded in detail. restored to 'near normalcy.'

When you exhausted your resources in the above, be humble and be understanding. Discuss with other consultants or with Dr. Kim about this matter. Tell the customer that we will discuss this matter at the company. We discuss the situation every Friday. That should be one of the regular topics of Friday meeting. If possible, tell the customer that we will call him on Friday when we have a meeting on how to help him.

Do not push the sales, or debate with the customer. Defensiveness. Evasiveness...Call them a few times even after most of the major interactions are completed.

Send a small gift that works for general population that will surely satisfy the person (Detox. Socks. Coupon.) with Dr. Kim's approval letter. (Wish you to try again. Special Treatment. <u>Establish a personal</u> relation with a specific consultant so that at least we can try again later)

Tell successful testimonies

Ask to take a break and see how that effects.

Customer should know about wrong way of taking Eleotin®.

No accusation. Do not ever try to make them believe that we are trying to prove them foolish. Point is not defense. But, understanding and consolation. We never promised a 100% cure. No such things exist. But, we want 100% satisfaction.

The most frequent case: Not so serious initial state. They were made to believe that they have diseases. If the problem with the customers is not resolved by now, do not be afraid to say that you do not know the solution. Phrase it in such a way that does not patronize the customer and express your own disappointment.

Issue D-2: Responding to a customer who reports that they are cured

POINTS:

- 1. Be sure to congratulate them. They joined thousands of others.
- 2. Explain that they need to keep a healthy lifestyle, nothing extreme just common sense.
- 3. Eleotin® when taken in smaller doses will prevent the return any of their metabolic problems
- 4. Display happiness that they saw benefits.
- 5. Make sure they know of all Eleotin® products that can help with other health issues
- 6. Refer to the testimony solicitation section of this manual.
- 7. Refer to the distributor solicitation section of this manual.

Issue E-1: Responding to people who displayed interest in becoming a distributor or affiliate

POINTS:

- 1. Make sure that they do not break the law. Make sure their advertising meets all standards and regulations, it will vary from city to city.
- 2. Emphasize their use of their own personal testimonies. These cannot be illegal so they are quite valuable.
- 3. Remind them that we have many products.
- 4. Recommend them to research as much as possible about Eleotin® through our website. Knowledge determines sales, so make sure they know enough about Eleotin® to sell it. Remind them that there are consultants always available to help if there are any questions.
- 5. If not confident about knowledge, tell them to rely on the DVD and our template letters until they are better versed.
- 6. Don't forget to remind them to sign the application form.

Issue E-2: Soliciting people to become distributors or affiliates

POINTS:

- 1. People will be skeptical, maybe even hostile, when declining the offer. We might seem to be running a multi-level marketing scheme. Assure them, carefully, that both our product and our business conduct are legitimate. Suggest nicely. Do not push or be too aggressive.
- 2. People who become distributor are able to make a healthy living. Be confident that we are actually helping them. If our products are expensive, becoming a distributor can be a solution.
- 3. Computer savvy clients with their own websites can become affiliates.
- 4. Use the sample case of the woman in Nebraska who, after experiencing benefits, started to buy Eleotin® on behalf of her friends and family. We suggested she become a distributor and now she earns up to \$3000 per month, from home.

Issue E-3: Soliciting new products to distributors

Points:

- 1. Dampens the fluctuations of revenue as well as increasing it.
- 2. Diversifies the options and clientele.
- 3. The non-diabetes products will actually increase the sales of diabetes products.
- 4. Some distributors do not even know the entire list of products. Send them one with brief descriptions.
- 5. Obesity, diabetes, cleanse & detox all have roughly the same amount of sales. Distributors want to know a general numerical estimate.
